On Thursday, October 30, 2025, the City of San Antonio hosted a Pre-Bid Meeting to provide information and clarification for the 2026 Street Rehabilitation Task Order Contract Package 4 project. Below is a list of questions that were asked at the pre-bid meeting. The City's official response to questions asked is as follows:

Question 1: Regarding the staging area, how do we stage on small streets?
Response: When staging within project limits is not possible, an individual staging plan will be evaluated and agreed to with the Project Management and Construction Management Team prior to construction.

Question 2: Is the Important Notice/Claims Information page required to be included with the bid bond document?
Response: Yes, the Important Notice/Claims Information page needs to be included as a part of the bid bond document, as the bid bond doesn't have the contact/claims information elsewhere if it is needed.

Question 3: Is there a reason why the Bid Opening was scheduled the week of Thanksgiving?
Response: In the interest of maximizing the number of bid responses, the Bid Opening date has been changed as specified in this Addendum 1.

Question 4: Do you anticipate a lot of addenda like other recent projects?
Response: No, the issues related to multiple addenda for several other projects have been resolved and are not expected to affect this project.
