Solicitation Type and Name: Request for Proposals – ARPA Combined – Nonprofits, Older Adults, Youth, & Mental Health

Solicitation Number: RFP 22-125; RFx 6100015939

**Description:** The City of San Antonio (City), Department of Human Services (DHS) seeks proposals from qualified Respondents interested in providing services in four community categories: nonprofit social services, Older Adults, Youth, and Mental Health. Within each community category, areas impacted by the pandemic were identified and are titled *COVID-19 Impact Area*. Within each *COVID-19 Impact Area*, DHS and Metro Health seek to fund specific programs and strategies targeted to mitigate the negative impact of COVID-19 on these communities. Respondents are encouraged to thoroughly review each of these fundable COVID-19 impact areas to determine which coincide with their organization's mission.

Only those organizations that are public entities, non-profit organizations, and charitable or faith-based organizations that have been in existence for at least two years as of the closing date for applications are eligible for consideration.

Respondents are prohibited from contacting City officials, as defined in [Section 2-62](#) of the Ethics Code, and employees, as defined in [Section 2-42](#) of the Ethics Code, regarding such a contract during the No-Contact Period. #### PROHIBITED CAMPAIGN CONTRIBUTIONS

**Notice Regarding Prohibition on Campaign or Officeholder Contributions for Individuals and Entities Seeking High-Profile Contracts.** Under Section 2-309 of the Municipal Campaign Finance Code, the following are prohibited from making a campaign or officeholder contribution to any member of City Council, candidate for City Council or political action committee that contributes to City Council elections beginning on the \*10th business day after a contract solicitation has been released through the 30<sup>th</sup> calendar day following the approval by City Council ("blackout" period):

- (1) Any individual seeking a high-profile contract;
- (2) Any owner, officer, officer of board, and executive committee member of an entity seeking a high-profile contract, excluding board officers and executive committee members of 501 (c)(3), 501(c) (4) and 501 (c)(6) non-profit organizations not created or controlled by the City whose board service is done strictly as a volunteer with no financial compensation and no economic gain from the non-profit entity;
- (3) The legal signatory of the high-profile contract;
- (4) Any attorney, lobbyist or consultant hired or retained to assist the individual or entity in seeking a high-profile contract;
- (5) Subcontractors hired or retained to provide services under the high-profile contract; and
- (6) Any first-degree member of the household of any person listed in (1), (2), (3) or (5) of this subsection.

A high-profile contract cannot be awarded to the individual or entity if a prohibited contribution was made by any of these individuals during the "blackout" period.

Questions submitted and the City's responses will be posted with this solicitation.

**\*For this solicitation, the first-day contributions are prohibited is September 23, 2023. The first day contributions may be made is the 31st day after the contract is approved at a City Council "A" Session.**
