Respondent will provide guidance on health related services to Head Start Program staff and Education Service Providers (i.e., ISDs) as requested. The on-site lead screenings and health services will be provided at all Head Start Program sites or as directed by DHS. Hemoglobin screenings will be provided at EHS sites only.
