Description: The City of San Antonio (the “City”) is soliciting proposals from Respondents to provide instructor-led training for Innovation Academy (IA) participants that equips them with the knowledge, skills, tools and techniques to enhance processes, solve problems and drive positive change in their respective service areas. Specific training topics and details are set forth within this Request for Proposals (“RFP”).

Insights gained from past projects and programs of Innovation have led to the discovery of strategies that aid in achieving successful outcomes. Innovation Academy is a program design to upskill City employees to effectively identify and lead improvement opportunities within their departments and across the City. Target Audience for Innovation Academy Training: City of San Antonio employees selected to participate in Innovation Academy. On any given training course/day there will be no more than 20 course participants and shall adhere to the timeframe detailed in the RFP. Each of the descriptions in the scope of work and participants make up a cohort for one (1) year. Therefore, there would potentially be one (1) cohort for the Innovation Academy Core and one (1) cohort for the Innovation Academy Plus each year.
