Description: The Neighborhood and Housing Services Department (NHSD) is seeking proposals from local Community Land Trusts and non-profit organizations (Respondent) with demonstrated experience and strong financial resources to acquire, rehabilitate, or build new single-family homes for affordable housing developments to prioritize income-based housing for low-income households with a restrictive affordability covenant of no less than 99 years. A designation is not required to apply for funding; however, the city will require Respondents to be designated as a Community Land Trust to be eligible for funding no later than 90 days from the time of award.
