Description: The City of San Antonio (City) Neighborhood and Housing Services Department is seeking proposals from Respondent's who shall provide environmental consulting services on an as-needed basis in a mutually agreed upon format. The work plan will be developed on a project-by-project basis. Typical HUD-funded projects could include single-family housing rehabilitation, single-family minor repair, public infrastructure improvements, facility improvements, commercial façade improvements, single-family new construction development, multi-family housing rehabilitation, and multi-family rental housing development. Respondent will be responsible for preparing for review and approval Environmental Review Records that are Categorically Excluded SUBJECT TO [§58.5](#), Environmental Assessments, and if needed, Environmental Impact Statements.
