

AN ORDINANCE **97401**

AUTHORIZING THE EXPENDITURE OF \$5,000 FROM THE DISTRICT 1 CONTINGENCY ACCOUNT FUND, \$1,000 FROM THE DISTRICT 8 CONTINGENCY ACCOUNT FUND, AND \$5,000 FROM THE DISTRICT 10 CONTINGENCY ACCOUNT FUND TO HELP DEFRAY THE CURRENT OPERATIONAL EXPENSES OF THE SAN ANTONIO SYMPHONY; AND WAIVING THE PROHIBITION AGAINST THE CONSIDERATION OF REQUESTS FOR THE EXPENDITURE OF CONTINGENCY FUNDS 90 DAYS PRIOR TO A COUNCIL ELECTION AS SET OUT IN ORDINANCE NO. 96399 IN ORDER TO ALLOW FOR SUCH EXPENDITURES; AS REQUESTED BY COUNCILMAN BOBBY PEREZ.

WHEREAS, Councilman Bobby Perez, District 1, has requested Council concurrence for the expenditure of \$5,000.00 from the Council District 1 Contingency Fund to the San Antonio Symphony, to help defray the current operational expenses of the San Antonio Symphony and the wavier of the prohibition against the consideration of requests for the expenditure of contingency funds 90 days to a council election as set out in Ordinance No. 96399 in order to allow for such expenditures; and

WHEREAS, in addition, Council Member Bonnie Conner, District 8 (\$1,000.00) and David Carpenter, District 10 (\$5,000.00) have requested Council concurrence for expenditure from their respective "District Contingency Account" in the amount indicated, similarly to assist the San Antonio Symphony.

WHEREAS, the City Council wishes to authorize the expenditures and the corresponding wavier as requested by Councilman Bobby Perez, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Bobby Perez, District 1, for reimbursement from the District 1 Contingency Account in the total amount of \$5,000.00 to the San Antonio Symphony is hereby approved and authorized. A copy of Councilman Perez's request is set out in Attachment I.

SECTION 2. The total amount of \$11,000.00 is encumbered for payment from the following Contingency Budget Accounts and is made payable to the San Antonio Symphony:

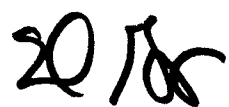

SECTION 3. The City Manager, or her designee, is hereby authorized to execute an agreement with the San Antonio Symphony in the amount of \$11,000.00 to help defray the current operational expenses associated with the San Antonio Symphony. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

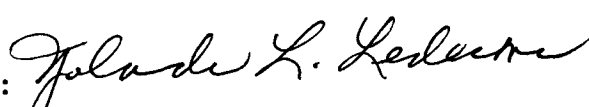
SECTION 5. This ordinance shall become effective on the tenth (10th) day after the passage hereof.

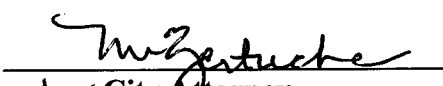
