

AN ORDINANCE

AMENDING THE RATE STRUCTURE FOR THE ADULT LEAGUE PARTICIPATION FEE FROM \$6.00 PER PARTICIPANT PER LEAGUE SEASON TO \$8.00 PER PARTICIPANT PER LEAGUE SEASON; AMENDING THE RATE STRUCTURE FOR THE TENNIS PARTICIPATION FEE FROM \$5.00 PER PARTICIPANT PER LEAGUE SEASON TO \$8.00 PER PARTICIPANT PER LEAGUE SEASON; AMENDING THE RATE STRUCTURE FOR THE MCFARLIN TENNIS CENTER LEAGUE/TOURNAMENT FEE FROM \$35.00 PER PARTICIPANT OR \$175.00 PER TEAM TO \$45.00 PER PARTICIPANT OR \$200.00 PER TEAM; AMENDING THE RATE STRUCTURE FOR THE SPANISH GOVERNOR'S PALACE USER FEE FOR SPECIAL EVENTS FROM \$75.00 PER HOUR WITH A TWO HOUR MINIMUM TO \$150.00 PER HOUR WITH A TWO HOUR MINIMUM; AMENDING THE RATE STRUCTURE FOR ALAMO PLAZA AND FOR DOWNTOWN PARK USAGE FEES TO INCLUDE A PHOTOGRAPHY RESERVATION FEE OF \$200.00 FOR THE FIRST FOUR HOURS AND \$40.00 FOR EACH ADDITIONAL HOUR; AMENDING THE RATE STRUCTURE FOR THE SAN ANTONIO BOTANICAL CENTER ADMISSIONS FEE FROM \$4.00 FOR ADULTS, \$1.00 FOR CHILDREN (AGES 3-13), \$2.00 FOR SENIORS/MILITARY/STUDENTS, \$3.00 ADULT GROUP RATE, \$0.50 CHILDREN GROUP RATE TO \$5.00 FOR ADULTS, \$2.00 FOR CHILDREN (AGES 3-13), \$3.00 FOR SENIORS/MILITARY/STUDENTS, \$4.00 ADULT GROUP RATE, \$1.00 CHILDREN GROUP RATE; ESTABLISHING A KID QUEST PROGRAM REGISTRATION FEE OF \$5.00 PER PARTICIPANT PER YEAR; ESTABLISHING A YOUTH LEAGUE PARTICIPATION FEE OF \$5.00 PER PARTICIPANT PER LEAGUE SEASON; ESTABLISHING AN ARTS BASED INSTRUCTIONAL CLASS REGISTRATION FEE OF \$25.00 PER PARTICIPANT PER CLASS; ESTABLISHING A LA VILLITA TEMPORARY VENDING PERMIT FEE OF \$20.00 PER DAY OR \$275.00 PER MONTH; ESTABLISHING PARKS AND RECREATION PLAT REVIEW FEES FOR PLAN REVIEW (SINGLE-FAMILY) OF \$140.00 PLUS \$25.00 PER PHASE, PLAN REVIEW (NON-SINGLE FAMILY) OF \$200.00 PLUS \$25.00 PER PHASE, PLAN AMENDMENT (SINGLE-FAMILY) OF \$100.00, PLAN AMENDMENT (NON-SINGLE FAMILY) OF \$160.00, SINGLE PHASE FEE OF \$140.00, VARIANCE FEE OF \$151.00, REISSUE OF EXPIRED LETTER OF CERTIFICATION OF \$25.00; ESTABLISHING A BOTANICAL GARDEN EDUCATION PROGRAM FEE OF \$30.00 PER PARTICIPANT PER CLASS; AND AMENDING THE CORRESPONDING SECTION OF THE CITY CODE TO REFLECT SUCH CHANGES.

WHEREAS, it is the policy of the City of San Antonio to assess fees to help offset the cost of operating City facilities and services; and

WHEREAS, as a part of the FY 2003/2004 City budget development process there has been identified the need to add new service and permit fees and to increase selected current service and permit fees in the Department of Parks and Recreation; and

WHEREAS, it is now necessary to amend the City Code of the City of San Antonio to reflect these changes; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. Section 22-9 (a) (4) of the City Code of the City of San Antonio, Spanish Governor's Palace user fee for parties and special events, shall be revised to be \$150.00 per hour, with a two-hour minimum.

Section 2. Section 22-14 of the City Code of the City of San Antonio shall be amended to conform to the following entrance fees at the San Antonio Botanical Garden:

Section 3. Section 22.16 of the City Code of the City of San Antonio shall be amended to read as follows:

"An adult athletic participation fee of \$8.00 per individual participant in adult athletic programs is hereby authorized."

Section 4. One dollar (\$1.00) of the adult athletic participation fee collected per individual participant for softball league programs shall be deposited into the Recreation Athletic Fund.

Section 5. Section 22-17 (a) of the City Code of the City of San Antonio shall be amended to add the following:

- (5) For film or photo production use, two hundred dollars (\$200.00) for the first four (4) hours of use, and forty dollars (\$40.00) for each additional hour or part thereof of use in any twenty-four hour period.

Section 6. In accordance with Section 22-21, Criteria for establishing fees for recreation related classes, the fee for Arts Based Instructional Classes shall be \$25.00 per participant per class for fine art, dance, music or gymnastics classes.

Section 7. In accordance with Section 22-21, Criteria for establishing fees for recreation related classes, the fee for Botanical Garden Education Classes shall be \$30.00 per participant per class for educational programs and activities.

Section 8. Section 22.21.1 of the City Code of the City of San Antonio shall be amended to be entitled "Participation Fees" and to add the following sections:

- (c) An annual participation fee of \$5.00 will be charged to each participant enrolled in the summer Kid Quest Program.
- (d) A youth league participation fee of \$5.00 will be charged to each participant per league season registration.

Section 9. Section 22-23 of the City Code of the City of San Antonio shall be amended to add Section 22-23.2, entitled La Villita Temporary Vending Permit, as follows:

The Director of Parks and Recreation will establish policies and procedures for a working artist program to allow local, working artists to demonstrate and sell unique, hand made products in designated areas within La Villita. Permit fees shall be as follows:

- (a) Working artist program daily rate \$ 20.00
- (b) Working artist program monthly rate \$275.00

Section 10. Section 22-136 of the City Code of the City of San Antonio shall be amended to add the following section:

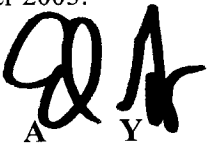
- (g) Tennis league participation fee:
 - (1) per individual participant per league, or \$ 45.00
 - (2) per team per league \$200.00

Section 11. The following fees shall be established for Parks and Recreation Department staff review of development plans, amendment of plans, development plats, and variances related to UDC 35-503 as needed by developers:

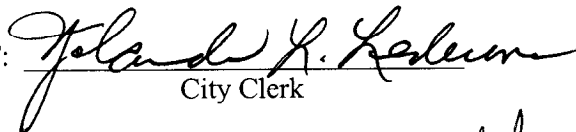
- (a) Development Plans
 - Single Family \$140.00 + \$25.00 /phase
 - Non Single Family \$200.00 + \$25.00/phase
- (b) Amending Plans
 - Single Family \$100.00
 - Non Single Family \$160.00
- (c) Single Phase Fee \$140.00
- (d) Variance \$151.00
- (e) Reissue expired Letter of Certification \$25.00

Section 12. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.

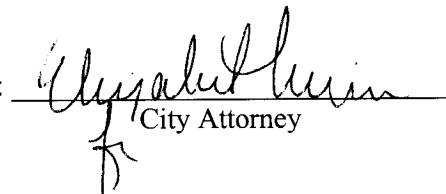
