

AN ORDINANCE **98201**

AUTHORIZING THE ACCEPTANCE OF \$9,226.00 IN ADDITIONAL FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) GRANT FUNDING FROM THE LOCAL BOARD OF THE FEDERAL EMERGENCY MANAGEMENT AGENCY'S EMERGENCY FOOD AND SHELTER NATIONAL BOARD PROGRAM FOR THE PROVISION OF RENTAL AND MORTGAGE ASSISTANCE BY THE CITY OF SAN ANTONIO DEPARTMENT OF COMMUNITY INITIATIVES, COMMUNITY ACTION DIVISION; REVISING THE BUDGET; AND AUTHORIZING THE EXECUTION OF ANY DOCUMENTS IN CONNECTION THEREWITH.

WHEREAS, in accordance with Public Law 101-467, an Emergency Food and Shelter National Board Program was established to receive federal funds from the Federal Emergency Management Agency and distribute such funds to local public and private organizations in connection with delivering emergency services to needy individuals; and

WHEREAS, the local Emergency Food and Shelter Program (EFSP) allocates the funds to local public and private organizations through the United Way, its fiscal administrator; and

WHEREAS, the local Emergency Food and Shelter Board has received additional funds and has awarded additional funding of \$9,226.00 to the City of San Antonio, Department of Community Initiatives, Community Action Division, to provide mortgage assistance, rental assistance, and first month's rental assistance for the homeless as they exit emergency shelters to transitional and permanent housing; and

WHEREAS, it is now necessary to accept the funds and authorize their utilization; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to accept additional Emergency Food and Shelter Program funding in the amount of \$9,226.00 from the local board of the Federal Emergency Management Agency's Emergency Food and Shelter National Board Program for the provision of rental and mortgage assistance by the City of San Antonio's Department of Community Initiatives, Community Action Division for the period of October 1, 2002 to September 30, 2003. The City Manager, or her designee, is authorized to execute any necessary documents in connection therewith. A copy of the Phase 21 National Board Reallocation Local Board Plan is attached hereto and incorporated herein for all purposes as **Attachment I.**

SECTION 2. The amount of \$9,226.00 is appropriated in Fund No. 26-056046 for expenditure in the program period, October 1, 2002 to September 30, 2003, as set out in the budget which is attached hereto and incorporated herein for all purposes as **Attachment II.**


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this ordinance.


SECTION 4. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.
