

AN ORDINANCE

RATIFYING THE SUBMISSION OF AN APPLICATION TO AND AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE LOCAL BOARD OF THE FEDERAL EMERGENCY MANAGEMENT AGENCY'S (FEMA'S) EMERGENCY FOOD AND SHELTER NATIONAL BOARD PROGRAM IN THE AMOUNT OF \$134,454.00 FOR THE PROVISION OF MORTGAGE AND RENTAL ASSISTANCE BY THE CITY OF SAN ANTONIO'S DEPARTMENT OF COMMUNITY INITIATIVES, COMMUNITY ACTION DIVISION, FOR THE PERIOD OF OCTOBER 1, 2003 TO SEPTEMBER 30, 2004; AUTHORIZING THE EXECUTION OF ANY AND ALL DOCUMENTS IN CONNECTION THEREWITH; AND APPROVING A BUDGET AND A PERSONNEL COMPLEMENT.

WHEREAS, in accordance with Public Law 101-467, an Emergency Food and Shelter National Board Program was established by Congress to receive federal funds from the Federal Emergency Management Agency and distribute such funds to local public and private organizations in connection with delivering emergency services to needy individuals; and

WHEREAS, the Emergency Food and Shelter Program Local Board allocates the funds to public and private organizations through the United Way of San Antonio and Bexar County; and

WHEREAS, the City of San Antonio has received funds from the Emergency Food and Shelter Program Local Board since 1983; and

WHEREAS, the Emergency Food and Shelter Program Local Board has awarded \$134,454.00 to the City of San Antonio, Department of Community Initiatives, Community Action Division, to provide mortgage assistance, rental assistance, and administrative funds in support of the homeless as they exit emergency shelters to transitional and permanent housing for the period of October 1, 2003 to September 30, 2004; and

WHEREAS, it is now necessary to ratify the submission of a grant application, accept the funds, approve a budget and a personnel complement and authorize the execution of all documents in connection with the acceptance of said funds; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Submission of a grant application to the Federal Emergency Management Agency's Emergency Food and Shelter Program Local Board for the provision of rental and mortgage assistance to homeless persons entering transitional or permanent housing by the City of San Antonio's Department of Community Initiatives, Community Action Division is ratified. A copy of the application is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The City Manager, or her designee, or the Director of the Department of Community Initiatives is authorized to accept a grant in the amount of \$134,454.00 from the Emergency Food and Shelter Program Local Board for the period of October 1, 2003, to September 30, 2004. The City Manager or her designee or the Director of the Department of Community Initiatives is authorized to execute any and all documents in connection therewith. A copy of the Notice of Award is attached hereto and incorporated herein for all purposes as Attachment II.

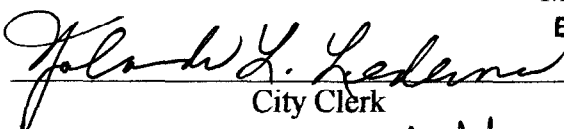
SECTION 3. The amount of \$134,454.00 is appropriated in Fund No. 26-056053 for expenditure in the program period, October 1, 2003 to September 30, 2004, as set out in the budget attached hereto and incorporated herein for all purposes as Attachment III.

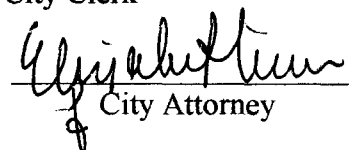
SECTION 4. The Personnel Complement, attached hereto and incorporated herein for all purposes as Attachment IV, is approved.

SECTION 5. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance shall become effective on April 4, 2004.
