

AN ORDINANCE

AUTHORIZING A FIVE (5) YEAR LICENSE AGREEMENT WITH ALAMO KIWANIS CHARITIES, INC., A NON-PROFIT CORPORATION, FOR THEIR OPERATION OF FIESTA NOCHE DEL RIO IN THE CITY'S ARNESON RIVER THEATER IN LA VILLITA IN COUNCIL DISTRICT 1, FOR AN ANNUAL CONSIDERATION OF \$7,000.00 IN 2004, \$7,500.00 IN 2005, \$8,000.00 IN 2006, \$8,500.00 IN 2007 AND \$9,000.00 IN 2008.

WHEREAS, City of San Antonio Ordinance No. 89709, passed and approved on May 6, 1999, authorized a five (5) year License Agreement with the Alamo Kiwanis Charities, Inc. for their operation of Fiesta Noche del Rio in the City's Arneson River Theater in City Council District 1; and

WHEREAS, Alamo Kiwanis Charities, Inc., a Texas Non-Profit Corporation, has requested a License Agreement to operate Fiesta Noche del Rio for 2004, 2005, 2006, 2007 and 2008; and

WHEREAS, said event has become a traditional annual event on the River Walk and attracts thousands of residents and visitors to downtown San Antonio; and

WHEREAS, said event represents a major source of funds for the Alamo Kiwanis Charities, Inc. programs for the children of our community; and

WHEREAS, in consideration of this License Agreement, Alamo Kiwanis Charities, Inc. will pay the City of San Antonio \$7,000.00 in 2004, \$7,500.00 in 2005, \$8,000.00 in 2006, \$8,500.00 in 2007 and \$9,000.00 in 2008 and will be required to provide for set-up, maintenance, housekeeping and take-down after the event; and

WHEREAS, said License Agreement is in the best interest of the City of San Antonio: **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. The City Manager or her designee is hereby authorized to execute a five year License Agreement with Alamo Kiwanis Charities, Inc. for their operation of Fiesta Noche del Rio for an annual consideration of \$7,000.00 in 2004, \$7,500.00 in 2005, \$8,000.00 in 2006, \$8,500.00 in 2007 and \$9,000.00 in 2008. A copy of said License Agreement, in substantially correct form, is affixed hereto and incorporated herein for all purposes as Attachment I.




Section 3. This ordinance shall be effective on and after June 13, 2004.
