

AN ORDINANCE **9 9 5 2 0**

AUTHORIZING AN INTERLOCAL COOPERATION CONTRACT WITH THE TEXAS DEPARTMENT OF INFORMATION RESOURCES TO PROVIDE INFORMATION RESOURCE TECHNOLOGY PROFESSIONAL STAFFING SERVICES THROUGH THIRD PARTY VENDORS, AND APPROVING A WORK ORDER THEREUNDER FOR A LIBRARY TECHNOLOGY ASSESSMENT FOR THE ALAMO AREA LIBRARY SYSTEM FOR A TOTAL SUM OF \$60,000.00, FUNDED BY A GRANT FROM THE TEXAS STATE LIBRARY.

WHEREAS, the Interlocal Cooperation Act (the "Act"), Chapter 791, Texas Government Code permits local governmental entities to enter into interlocal cooperation contracts for the performance of governmental functions, including administrative functions, such as procurement, in order to promote efficiencies and effectiveness; and

WHEREAS, the Texas Department of Information Resources ("DIR") offers other governmental entities the ability to participate in its information resource technology professional services staffing program, thereby, facilitating administration of such procurements by local government representatives who wish to utilize these services; and

WHEREAS, the City wishes to engage the services of DIR, by means of an interlocal cooperation contract for resource technology services ("ILC"), and issuance of work orders for particular services there under, as needed; and

WHEREAS, the City wishes to issue a work order to DIR pursuant to the ILC for staffing services in connection with a library technology assessment for the Alamo Area Library System for a total sum of \$60,000.00, to be funded by a grant from the Texas State Library; and

WHEREAS, the assessment will cover 46 libraries in a 21 county area, include an inventory of present hardware, software, and structural wiring, diagram the current networks, and provide a technology plan, recommending upgrades for each location; and

WHEREAS, the ILC will also allow the City to utilize DIR for future information resource technology staffing services, as may be subsequently approved by the City; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The interlocal cooperation contract for resource technology services with the Texas Department of Information Resources is hereby approved, a copy of which is attached hereto and incorporated herein for all purposes as Exhibit I. The initial work order for the library technology assessment attached to Exhibit I as Attachment A is also hereby approved. The City Manager or her designee, or the Director of Purchasing & General Services is hereby authorized to execute the ILC and any documents incident to and necessary to effectuate the ILC, to renew the ILC on an annual basis, and to pay any fees associated therewith, now and in the future, subject to availability of funds. The City Manager or her designee, or the Director of Purchasing & General Services is also hereby authorized to amend the ILC, including amendments that result from the execution of additional work orders in amounts that do not exceed \$25,000 for any particular work order, so long as funding is provided for in the budget. Execution of work orders exceeding \$25,000 shall require additional City Council approval.

SECTION 2. Funding for this ordinance in the amount of \$60,000.00 will be from Fund No. 26-018122, Index Code 748400, and said amount will be encumbered when Purchasing issues the purchase order and payment is hereby authorized to the Texas Department of Information Resources for \$60,000.00.

SECTION 3. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 4. This ordinance shall take effect on August 15, 2004.


