

AN ORDINANCE **99739**

AMENDING VARIOUS FEES CHARGED FOR PARKS AND RECREATION RELATED PROGRAMS, SERVICES, FACILITIES AND CLASSES THROUGH THE PARKS AND RECREATION DEPARTMENT, AND AMENDING THE CORRESPONDING SECTIONS OF THE CITY CODE TO REFLECT SUCH CHANGES.

* * * * *

WHEREAS, it is the policy of the City of San Antonio to assess fees to help offset the cost of operating City facilities and services; and

WHEREAS, as a part of the FY 2004/2005 City budget development process there has been identified the need to add new service and permit fees and to increase selected current service and permit fees in the Department of Parks and Recreation; and

WHEREAS, it is now necessary to amend the City Code of the City of San Antonio to reflect these changes; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. Section 7-54 (2) of the City Code of the City of San Antonio, Charges for interments, services, grave spaces and foundation sales, shall be amended to conform to the following increased fees:

(2) Optional Services	
b. tent, chairs, etc.	\$150.00
c. vases	\$ 25.00

Section 2. Section 7-54 (6) of the City Code of the City of San Antonio, Charges for interments, services, grave spaces and foundation sales, shall be amended to read as follows:

(6) Foundation Sales	
a. Standard foundation sales	\$ 0.50 per square inch
b. Infant headstone setting fee	\$75.00

Section 3. Section 22-7 of the City Code of the City of San Antonio, Charges for use of baseball, softball diamonds, gymnasiums, shall be amended to conform to the following increased fees:

- (1) Baseball diamonds:
 - a. Ten dollars (\$10.00) per hour before 5:00 p.m.

- b. Fourteen dollars (\$14.00) per hour after 5:00 p.m.
- c. One hundred fifty dollars (\$150.00) all day up to 12 hours with \$20 for each additional hour

(2) Softball diamonds:

- a. Ten dollars (\$10.00) per hour before 5:00 p.m.
- b. Fourteen dollars (\$14.00) per hour after 5:00 p.m.
- d. Class B fields: One hundred fifty dollars (\$150.00) all day up to 12 hours with \$20 for each additional hour

Section 4. Section 22-10 (a) of the City Code of the City of San Antonio, Fee for use of park pavilions, shall be amended to conform to the following increased fees:

(a) Monday through Thursday	\$40.00
Friday, Saturday, Sunday and holidays	\$80.00

Section 5. Section 22-11 of the City Code of the City of San Antonio, Fee for use of Mateo Camargo Park, shall be amended to conform to the following increased fees:

(1) Attendance 400 or less	\$ 350.00
(2) Attendance 401 – 1,000	\$ 650.00
(3) Attendance 1,001 or more	\$1,000.00
(4) Pavilion only	\$ 250.00

Section 6. Section 22-12 of the City Code of the City of San Antonio, Fee for use of Rosedale Park mass picnic facility, shall be amended to conform to the following increased fees:

(1) Attendance 400 or less	\$ 550.00
(2) Attendance 401 – 1,000	\$1,000.00
(3) Attendance 1,001 or more	\$1,500.00
(4) Pavilion only	\$ 250.00

Section 7. Section 22-13 of the City Code of the City of San Antonio, Admission fees for San Antonio Natatorium, shall be amended to conform to the following increased fees:

(e) Learn to swim and water aerobics	\$ 25.00

Section 8. Section 22-14 (a) of the City Code of the City of San Antonio shall be amended to conform to the following entrance fees and modified age categories at the San Antonio Botanical Garden:

(1) General Admission, ages 3 through 13	\$3.00
(2) General Admission, 14 through 59	\$6.00
(3) General Admission, age 60 and over	\$4.00
(4) Tour rate (15 or more persons), ages 3 through 13	\$2.00
(5) Tour rate (15 or more persons), age 14 and over	\$5.00

(7) Student/Military

\$4.00

Section 9. Section 22-14 (a)(6) of the City Code of the City of San Antonio Admission to Viva Botanica shall be deleted and Section 22-14(a)(7) Student/Military shall be re-numbered to become Section 22-14 (a)(6).

Section 10. Section 22-17 (b) (1) and (2) of the City Code of the City of San Antonio, Park usage fee for special events within City parks, shall be amended to read as follows:

- (1) Small events with minimum set up requirements \$ 50.00
- (2) Larger events with set up or special activities
 - Attendance 400 or less \$ 350.00
 - Attendance 401 to 1,000 \$ 650.00
 - Attendance 1,001 or more \$1,000.00

Section 11. Section 22-18 of the City Code of the City of San Antonio, Stage facility user fees, shall be amended to conform to the following increased fees:

- (1) Showmobile and stagemobile per 8 hours \$ 575.00

Section 12. Section 22-20 of the City Code of the City of San Antonio, Fees for use of football, soccer or rugby fields, shall be amended to read as follows:

The following fees shall be collected by the director of parks and recreation department for rental of football, soccer or rugby fields:

- 1. Ten dollars (\$10.00) per hour before 5:00 p.m.
- 2. Fourteen dollars (\$14.00) per hour after 5:00 p.m.
- 3. One hundred fifty dollars (\$150.00) all day up to 12 hours with \$20 for each additional hour.

Section 13. The following new recreation and cultural program fees are authorized:

- 1. Recreation Program Holiday/Spring Break Camp Supply Fee of \$5.00 per Holiday Camp and \$5.00 per Spring Break Camp per participant per class;
- 2. Adult and Senior Program Participation Fee of \$5.00 per participant per year
- 3. Specialty Workshop/Clinic Fee for cultural program classes of \$25.00 for a one-day (four hour) workshop and \$40.00 for a two-day workshop (four hours per day)

4. Weekly Specialty Camp Fee for cultural program classes, which will offer four separate classes each day throughout a given week, with participants having the option of attending the entire camp or only selected classes within the camp as follows: Community Center Classes - \$75.00 per week or \$30.00 per class; Downtown Classes - \$150.00 per week or \$35.00 per day;
5. Contracted Cultural Program Classes at all community centers, fees to be determined, and revenue divided with 70% to the instructor and 30% to the City;
6. Annual registration fee for each participant in the Therapeutic Recreation Program Summer Youth Day Program of \$5.00 per participant per year;
7. Monthly participation fee for each participant in the Therapeutic Recreation Program Adult Day Program of \$20.00 per participant per month;

Section 14. Section 22-24 (a) of the City Code of the City of San Antonio, Fees for use of Eisenhower Park picnic facilities, shall be amended to conform to the following increased fees:

(1) Attendance 400 or less	\$ 550.00
(2) Attendance 401-1,000	\$1,000.00
(3) Attendance 1,001 or more	\$1,500.00
(4) Pavilion only	\$ 250.00

Section 15. Section 22-32 of the City Code of the City of San Antonio, Community centers, senior centers and clubhouse rental fees shall be amended to conform to the following increased fees:

(1) Gym practice	\$ 20.00 per hour
(2) General Use	\$ 30.00 per hour
(3) Special Events Use	\$ 55.00 per hour

Section 16. Section 22-136 of the City Code of the City of San Antonio, McFarlin Tennis Center fees, shall be amended to conform to the following increased fees:

(a) Court fees before 5:00 p.m.	
(3) Adult	\$ 2.50 per person, per hour
(b) Court fees after 5:00 p.m.	
(3) Adult	\$ 3.50 per person, per hour

Section 17. Section 22-136 (e) of the City Code of the City of San Antonio, McFarlin Tennis Center fees, shall be revised to delete "Except as follows:" and all exceptions listed in subsections (1) through (3).

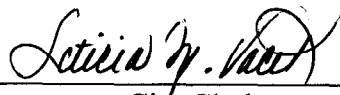
Section 18. This ordinance shall be effective on and after October 1, 2004.

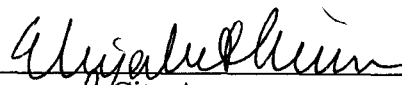
