

AN ORDINANCE **100797**

AUTHORIZING THE EXECUTION OF A GRANT AGREEMENT AMENDMENT WITH THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT; REPROGRAMMING \$29,904.00 FOR DWYER AVENUE CENTER OPERATIONS IN CONNECTION WITH THE 2001 SUPPORTIVE HOUSING PROGRAM FOR THE PERIOD OF FEBRUARY 1, 2005 THROUGH MAY 15, 2005; AND APPROVING A REVISED BUDGET.

WHEREAS, on January 13, 2005, pursuant to Ordinance No. 100285, the City Council authorized the execution of a Grant Agreement Amendment with the U.S. Department of Housing and Urban Development (HUD) reprogramming \$34,176.00 from Dwyer Avenue Center Operations and Maintenance to pay lease costs to the San Antonio Housing Authority (SAHA) for 16 families to be housed at a SAHA complex; and

WHEREAS, on January 13, 2005, pursuant to Ordinance No. 100286, the City Council authorized the execution of a contract with SAHA to provide said lease payments to SAHA; and

WHEREAS, the agreement with SAHA was not executed and therefore, the sixteen (16) Dwyer Avenue Center families were not relocated to the SAHA complex; and

WHEREAS, the City of San Antonio's Dwyer Avenue Center continued to accrue operational expenses of \$29,904.00 for the sixteen (16) families residing at the Dwyer Avenue Center; and

WHEREAS, it is now necessary to reprogram \$29,904.00 from lease costs to Dwyer Avenue Center Operations and Maintenance; and

WHEREAS, HUD has agreed to a Grant Agreement Amendment reprogramming funds from lease costs to Dwyer Avenue Center Operations and Maintenance; and

WHEREAS, it is now necessary to execute a Grant Agreement Amendment with HUD and to revise the budget for the 2001 Supportive Housing Program; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Interim City Manager, or his designee, or the Director of the Department of Community Initiatives is authorized to execute a Grant Agreement Amendment to the 2001 Supportive Housing Program (SHP) authorizing the reprogramming of \$29,904.00 from lease costs to Dwyer Avenue Center Operations in connection with the 2001 Supportive Housing

Program for the period February 1, 2005 through May 15, 2005. A copy of said Grant Agreement Amendment is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The revised budgets for Fund No. 26-054000, Internal Order No. 138000000179 entitled "SHP 2001 Operations and Maintenance" and Internal Order No. 138000000311 entitled "2001 Supportive Housing Programs, attached hereto and incorporated herein for all purposes as Attachment II is hereby approved.


SECTION 3. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, subject to concurrence by the Interim City Manager, or the Interim City Manager's designee, may correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP internal orders and SAP GL Accounts as necessary to carry out the purpose of this ordinance.


SECTION 4. This ordinance shall become effective on and after May 15, 2005.
