

AN ORDINANCE 2006-06-29-0805

AUTHORIZING THE EXECUTION OF TWO NO-COST CONTRACT AMENDMENTS WITH SAN ANTONIO METROPOLITAN MINISTRY (SAMMINISTRIES) AND THE SALVATION ARMY, TO ADJUST THE CONTRACT BUDGETS AND FACILITATE TIMELY EXPENDITURE OF FUNDS FOR THE SUPPORTIVE HOUSING PROGRAM.

WHEREAS, the San Antonio Metropolitan Ministry (SAMMinistries) provides transitional housing and supportive services to homeless families, and the Transitional Living and Learning Center, which can house forty (40) families, operates at 95% occupancy; and

WHEREAS, the Salvation Army's Shining Star Program (Salvation Army) provides transitional housing and supportive services to homeless single women who suffer with mental illness, and this program, which can house eight women, operates at 100%; and

WHEREAS, the City of San Antonio (City) desires to continue purchasing housing and supportive services for homeless families and chronically homeless individuals through the Supportive Housing Program (SHP), and the SHP programs are integral parts of the City's Ten-Year Plan to End Chronic Homelessness; and

WHEREAS, it is now necessary to amend a delegate agency contract with SAMMinistries in order to transfer funds from the budget line item for Communications and Maintenance/Repair-Building to the budget line item for Machinery and Equipment; and

WHEREAS, it is now necessary to amend a delegate agency contract with the Salvation Army in order to transfer funds from the budget line item for Salaries and Fees to Professional Services to the budget line item for Food, Furniture and Educational Supplies; and

WHEREAS, city desires to amend these two contracts, which will have no additional costs to the City, and will have no impact on the delivery of services other than to facilitate the timely expenditure of the grant funds; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, or the Director of the Department of Community Initiatives is authorized to execute a no-cost contract amendment with the San Antonio Metropolitan Ministry (SAMMinistries) in order to transfer funds from one budget line item to another budget line item in order to facilitate the timely expenditure of funds. The contract amendment with SAMMinistries is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The City Manager, or her designee, or the Director of the Department of Community Initiatives is further authorized to execute a no-cost contract amendment with the Salvation Army in order to transfer funds from one budget line item to another budget line item in order to facilitate the timely expenditure of funds. The contract amendment with the Salvation Army is attached hereto and incorporated herein for all purposes as Attachment II.

SECTION 3. There is no fiscal impact as a result of this ordinance.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall be effective on and after July 9, 2006.
