#### SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the amendment of Ordinance No. 92274, passed August 10, 2000, which accepted a grant from the Bureau of Justice Assistance, to assist in the purchase of ballistic vests for law enforcement personnel. The amendment will accept fourth year funding in the amount of \$13,294.27 and increase the total grant budget to \$115,035.29.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

This grant provides funds to assist in the acquisition of ballistic vests for San Antonio law enforcement officers. The Bureau of Justice Assistance (BJA), the granting agency, provided this as a multi-year grant, allocating additional funds each calendar year. This ordinance will accept the fourth year allocation of \$13,294.27, which will be added to the project, increasing the total budget to \$115,035.29.

#### **POLICY ANALYSIS**

This ordinance complies with City Council direction to seek alternative funding when available.

#### **FISCAL IMPACT**

The grant provides up to 50% of the cost of ballistic vests for San Antonio law enforcement officers. This amendment will increase the total project budget to \$115,035.29.

## **COORDINATION**

This ordinance request has been coordinated with Finance, City Attorney's Office, and the Office of Management and Budget.
