Zoning Request: "R-4" Residential Single Family District and "O-2" Office District to "C-2NA" Commercial Non Alcoholic Sales District.

<u>Lucy Kephart</u>, 100 W. Houston Street, representing the applicant, stated they are requesting this change in zoning to operate office furniture sales. She further stated they have made several attempt in contacting North Central Neighborhood Association and received no response. She further stated the structure would remain in tact however they will renovate the interior of the structure. She also stated they would provide a landscape buffer

Evan Wedick, 11119 Aldean Street, stated the name of the business is Payless Office Furniture and they have been in business since 1951. He further stated the exterior of the building would remain the same. The only renovating will be on the interior of the building.

Staff stated there were 35 notices mailed out to the surrounding property owners, 4 returned in opposition and 7 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
