She feels there is already enough businesses in and around the neighborhood that sale alcohol. She further stated is frustrated with having to see discarded beer cans and bottles. Some of these businesses would not allow drinking on the premises so the customers would congregate on the church property and then urinate on her back yard.

Staff stated there were 13 notices mailed out to the surrounding property owners, 2 returned in opposition and 4 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

"C-3NA" Commercial Non-Alcoholic Sales District to "C-3R"

Commercial Restricted Alcohol Sales District.

Jimmie Leal, 4421 Culebra, stated he is requesting this change in zoning to allow a liquor store with off premise consumption. He stated the proposed liquor store would be approximately 275 feet from the nearest residence with a privacy fence. He stated he had a business at this location 12 years ago and his business did very well. This property is surrounding by other commercial uses and he feels this is an appropriate location for his business.

OPPOSE

<u>Lulu Francois</u>, 5354 San Siemon, stated she is in opposition of this request. She is concerned with sales of alcohol in the area. This neighborhood is surrounding by convenient stores and bars that sale alcohol. She stated is frustrated with having to see discarded beer cans and bottles in and around the neighborhood. Customers from these surrounding alcohol businesses would gather on the church property and then urinate on her back yard.

Rosa Mary Perez, 1330 Lavine, President of Culebra Park Neighborhood Association, stated they do not support this request. She stated they feel that having a safe neighborhood and a family oriented business is a health environment for the community.
