The northwest corner of Porter Street and South New Braunfels

Applicants Proposal: To permit the sale of snow cones, ice cream, candy and light foods.

**Staff Recommendation:**

The subject property is currently vacant and located on the corner of a major arterial and an intersecting local street. There is a bus stop on the corner. An "NC" Neighborhood Commercial District is appropriate at this location. The proposed use is relatively small in scale and would serve residents and pedestrians in the residential neighborhood and those individuals waiting at the bus stop. "C-2" commercial zoning is located across the street on South New Braunfels Avenue and a pawn shop is located directly across from the subject property on Porter Street. As stated in the Unified Development Code (U.D.C.), a 15 foot Type B buffer and a six foot fence is required along the subject property lines. At the rear property line, the applicant may elect to provide a 6 foot solid fence in leau of the 15 foot buffer.
