Applicant: Seda Consulting Engineers, Inc.

Zoning Request: "R-6" Residential Single Family District to "R-4" Residential Single

Family District on 28.516 acres of land out of NCB 15173 and from "R-6" Residential Single Family District to "C-3" Commercial

District on 11.732 acres of land out of NCB 15173.

Ken Brown, 111 Soledad, representing the applicant, stated after meeting with the zoning staff they have agreed with staff's recommendation of the "C-3" on 2.663 acre tract and the remainder of the tract will remain "C-2". He also stated they are also amending single-family portion to "R-5". He feels this is in compliance with planning principals and with the zoning staff's recommendation. He also stated he contacted the PACE Neighborhood Association and he has also Councilman's staff at which they are in support. He further they will develop approximately 140 units.

<u>Floyd Holsonbake</u>, 110 Shadow Valley, stated he resides within this area. He would like more clarification as to what will be developed on the subject property.

Staff stated there were 67 notices mailed out to the surrounding property owners, 12 returned in opposition and 8 returned in favor and no response from People Active in Community Effort Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

### **COMMISSION ACTION**

The motions was made by Commissioner Avila and seconded by Commissioner Cardenas-Gamez to recommend approval of the amended request.

- 1. Property is located on 40.248 acres of land out of NCB 15173 at 6600 Block of Southwest Loop 410 at Ray Ellison Boulevard and Southwest Loop 410.
- 2. There were 67 notices mailed, 12 returned in opposition and 8 returned in favor.

3. Staff recommends denial as requested and approval of "R-4".
