Authorization for a Mini-Storage Facility exceeding 2.5 acres.

Bill Kaufman, 100 W. Houston, representing the owner, stated they are requesting this change in zoning to build office buildings on the front portion of the property and the remaining portion will have a retail use which will be used for mini warehouse storage facilities.

Staff stated there were 8 notices mailed out to the surrounding property owners, 0 returned in opposition and 4 returned in favor.
