#### SUMMARY AND RECOMMENDATIONS

This ordinance ratifies services and appropriates funds in the total amount of \$2,450.00, payable to GGI Engineers, a non-MBE firm, for surveying services in connection with the Yellowstone from Mission Road to Roosevelt Project, an authorized Community Development Block Grant (CDBG) funded project, located in Council District 1.

Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

This ordinance provides compensation to GGI Engineers, for surveying services related to the Yellowstone from Mission Road to Roosevelt project. The surveying service was approved in order to avoid a 6 week downtime with estimated delay charges of \$18,000.00 from the contractor. The services to be provided include recover centerline, check construction benchmarks and tie-in elevations, stake construction, prepare cut sheets (14 field hours).

The Yellowstone from Mission Road to Roosevelt project consists of reconstruction of Yellowstone, from Mission Road to Roosevelt, to a street width of 30 feet to include curbs, sidewalks, driveway approaches and necessary drainage improvements.

### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to construct previously approved Community Development Block Grant funded Capital Improvement Projects.

#### **FISCAL IMPACT**

This is a one-time capital improvement expenditure. The project will be funded in the amount of \$2,450.00 from Community Development Community Block Grant (CDBG) funds and authorized payable to GGI Engineers.

## **COORDINATION**

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.


