Robert Marotta, 221 Casa Blanca, stated he is proposing to operate a family oriented restaurant on the subject property. He stated he has met with the Tobin Hill Neighborhood Association who is in support of this request.

OPPOSE

<u>Dr. Jacqueline Von Honts, PhD</u>, 423 E. Grayson, stated that she operates an Art School for young students, which is across from the subject property. She stated that she is in support of the restaurant operation however she does not support the sale of alcohol. She is concerned that the sale of alcohol would have a negative impact on the young students that attend the Art School.

REBUTTAL

Robert Marotta, requested Commission visit her Art School. He stated the students live on the property that Dr. Von Honts claims is an Art School. He further stated he would like to amend his request to "C-1".

Staff stated there were 42 notices mailed out to the surrounding property owners, 2 returned in opposition and 3 returned in favor and the Tobin Hill Neighborhood Association is in favor and there was no response from Tobin Hill Residents Association and Alta Vista Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

COMMISSION ACTION

The motion was made by Commissioner Martinez and seconded by Commissioner Morell to recommend approval of "C-1".
