SUMMARY & RECOMMENDATION

In order to relocate and increase necessary fuel storage facilities at San Antonio International Airport ("Airport"), the proposed ordinance authorizes the execution of a new 20-year ground lease for the development of a new aboveground Fuel Storage Facility with Nayak Aviation Corporation ("Nayak"). The lease is for 123,274 square feet of ground space at an annual rental of \$49,309.60 (123,274 square feet times \$.40 per square foot per year).

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The lessee is a full-service Fixed Based Operator (FBO) that provides 24 hour services to commercial airlines, private aircraft and corporate business aircraft at another Airport site. Nayak has been a tenant at San Antonio International since 1961. It is a family-owned and operated aviation business, and is one of the oldest continuously operated businesses on the Airport. Nayak currently employs 60 individuals at its Airport facility with an estimated annual payroll of \$1,500,000. The need to develop a new fueling facility results from the planned future recapture by the City of the current Nayak leasehold and fueling facilities in connection with the Terminal Expansion Project.

The Fuel Storage Facility Project will include two 5,000 barrel (440,000 gallons) fuel tanks to store Jet-A fuel and three ten thousand gallon tanks to store diesel, unleaded gasoline, and General Aviation 100 Octane AVGAS. The tenant-financed facility, which will cost approximately \$500,000, will also include loading and unloading docks.

POLICY ANALYSIS

The proposed ordinance is in keeping with Council policy as leases at the Airport have been permitted in the past. Further, the proposed lease will assist a current Airport tenant with its business growth and will facilitate the continuation of necessary services at the Airport.

FINANCIAL DATA

Annual ground rental for the new Nayak lease will be \$49,309.60 (123,274 square feet times \$.40 per square foot per year equals \$49,309.60). This rental is based upon an appraisal of the premises and represents a fair market value return to the City.

COORDINATION

This item has been coordinated with the Asset Management Department and the City Attorney's Office.
