Lookout Way, but lacking street frontage (land locked).

Applicants Proposal:

To make the zoning consistent with adjacent properties. The subject

site is to be developed in conjunction with lots currently fronting

Lookout Way.

Staff Recommendation:

Approval.

This residentially zoned tract is completely surrounded by commercial and industrial zoning, isolating it from other residential parcels. The area is characterized by scattered vacant tracts and office/industrial uses. A railroad line right-of-way with tracks to the north separate the nearest residential subdivision from commercial activity on the south side of Lookout Road.

"C-3 NA" would be an appropriate zoning classification for the subject tract considering adjoining zoning and nearby uses.

Note: This property will have to be properly platted in order to obtain a building permit.
