#### SUMMARY AND RECOMMENDATIONS

This ordinance authorizes funds in the amount of \$394,741.59, payable to the Texas Department of Transportation (TxDOT), related to a funding shortfall for construction costs according to the final third party accounting in connection with Rittiman Road from Austin Highway to Harry Wurzbach project, an authorized Metropolitan Planning Organization (MPO) project, located in Council District 10. This is a multi-funded project funded from General Obligations of the City.

Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

As part of the implementation of Urban Street Program (USP) projects, it is the City's responsibility to fund engineering, right of way acquisition, twenty percent (20%) of pavement construction, and 100% of curbs, sidewalks, driveways, and retaining wall costs. This ordinance will provide for the reconciliation of final quantities used to complete this project and serve as final payment to TxDOT. The Rittiman Road from Austin Highway to Harry Wurzbach project included base repair, pavement milling and asphalt overlay of 2-lane roadway to include 6-foot sidewalks at the curb on the North side only with 5-foot bike lane on each side. This project was completed March 2002.

#### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to participate in the development and construction of City selected and approved MPO projects which are approved annually by Council.

#### FISCAL IMPACT

This is a one-time capital improvement expenditure. Funds in the amount of \$394,741.59 are available from General Obligations of the City and authorized payable to the Texas Department of Transportation.

## **COORDINATION**

This request for ordinance has been coordinated with the Office of Management and Budget, the Finance Department and the Texas Department of Transportation.


