SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager to execute a contract amendment that provides cash support totaling \$18.808.00 from the Texas Department of Health (TDH) to augment the ongoing Tuberculosis Prevention and Control Project in the San Antonio Metropolitan Health District (SAMHD) for the period September 1, 2002 through August 31, 2003. This ordinance will also revise the Public Health State Support Project 2002/2003 Fund, revise the project budget of the Public Health State Support Project 2002/2003 - State account, and approve the personnel complement.

Staff recommends approval.

BACKGROUND

The City Manager was authorized to execute the Public Health State Support Project 2002/2003 contract with TDH through an ordinance passed and approved on August 9, 2001. This contract includes thirteen (13) contract amendments that were approved in previous ordinances, and currently provides \$5,297,790.00 in cash support, \$54,312.00 in-kind support, and \$5,218,981.00 in contract (fee-for-service) support.

TDH has now offered a contract amendment that will furnish \$18,808.00 in cash to augment the Tuberculosis Prevention and Control Project of the SAMHD. This project investigates, diagnoses and manages suspected cases of tuberculosis. The TB Clinic has over 6,500 patient visits and the TB outreach staff make over 11,500 patient home visits each year.

The personnel complement of this activity consists of the four (4) full time positions previously approved and one (1) new part-time position, Health Program Specialist, to take x-rays in the clinic. The new position will create an annual cost savings of \$4,000.00 over the present system of contracting out for these personnel services.

POLICY ANALYSIS

Acceptance of this grant from TDH will continue the long-standing practice of utilizing Federal and State aid to support the local public health programs of the City.

FINANCIAL IMPACT

This TDH contract amendment provides \$18,808.00 in cash to augment the support of the Tuberculosis Prevention and Control Project of the SAMHD. These funds cover the cost of a new part-time staff person to operate the clinic x-ray machine. Acceptance of this contract award will place no demands on the City General Fund.

COORDINATION

The Finance Department has approved the proposed project budget.

SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.
