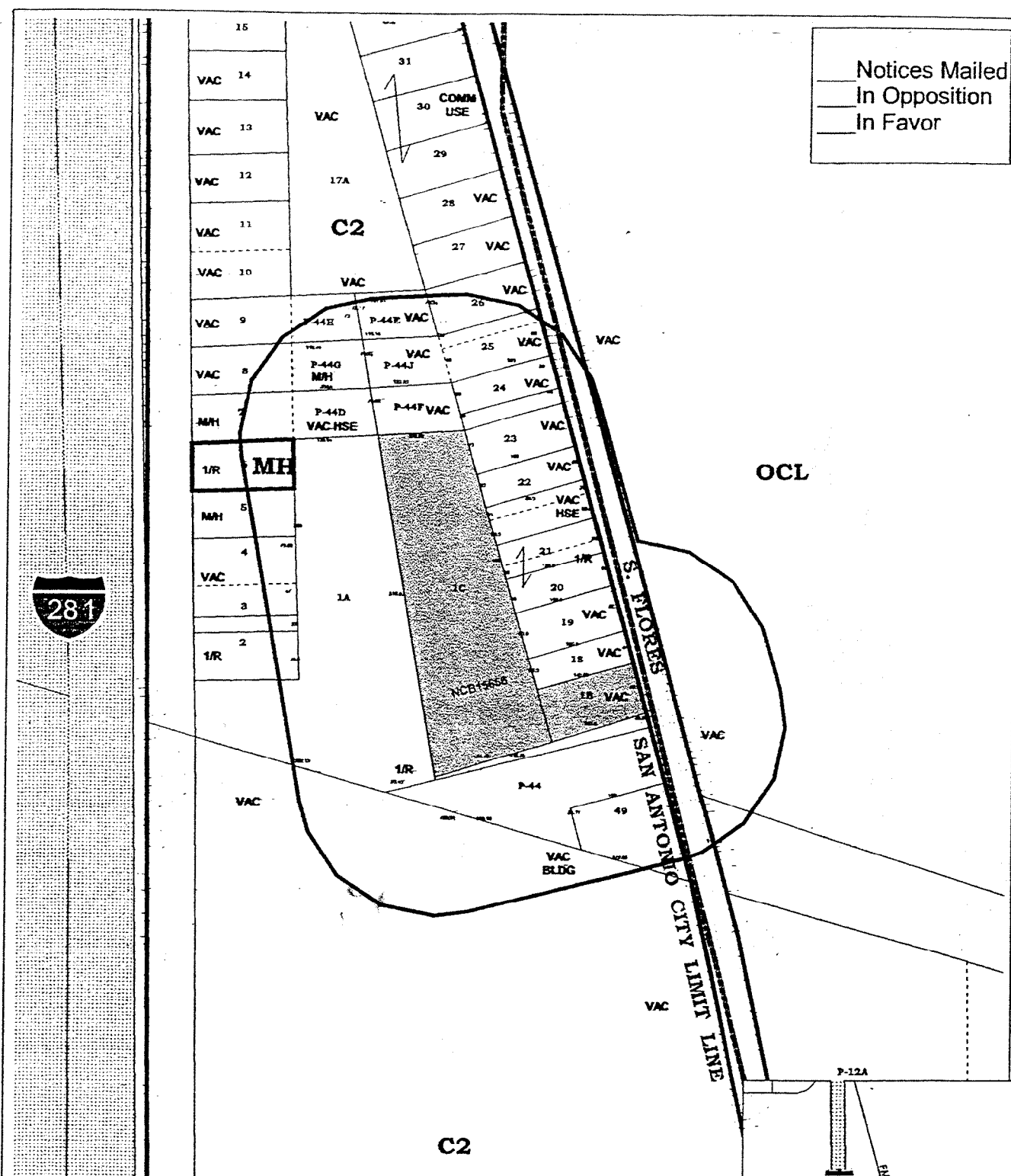

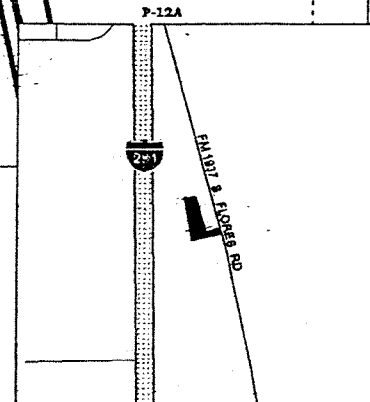

Applicant: Tomas & Amalia Guerrero

Zoning Request: "C-2" Commercial District to "MH" Manufactured Housing District.

Applicant/Representative was not present.

OPPOSE

Norma Garcia, 13403 Bell Drive, stated she is in opposition of this request. She is concerned that this manufactured home would decrease the property values within this area. She expressed concerns with the element that this could bring into the area.

REBUTTAL

Rose Lozano, stated the new manufactured homes that would be placed on the property would enhance the appearance of the area. She does not feel this would decrease property values.

Staff stated there were 27 notices mailed out to the surrounding property owners, 0 returned in opposition and 5 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

COMMISSION ACTION

The motion was made by Commissioner Hophan and seconded by Commissioner Grau to recommend denial.

1. Property is located on Lot 1B and 1C, NCB 15666 at 12132 Highway 281 South.
