SUMMARY AND RECOMMENDATIONS

This ordinance authorizes funds in the amount of \$50,111.17, payable to the Texas Department of Transportation (TxDOT), related to the City's share of twenty percent (20%) of construction cost in connection with Isom from Ramsey to US 281 project, an authorized Metropolitan Planning Organization (MPO) project, located in Council District 9. This project is funded from 2002 Certificates of Obligations.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

As part of the implementation of Metropolitan Planning Organization (MPO) Surface Transportation Program projects, it is the City's responsibility to fund engineering, right of way acquisition, and twenty percent (20%) of construction cost. This payment will satisfy the City's financial escrow commitment in order for TxDOT to go forward with the completion of the construction contract for the Isom Road from Ramsey to US 281 project. This project provides for the reconstruction of Isom Road from Ramsey to US 281, modifying the existing 2-lane street to a 2-lane street with a continuous center turning lane, 6-foot sidewalks at the curb and necessary drainage. This project was advertised for bids by TxDOT December 2002 and will begin construction February 2003.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to participate in the development and construction of City selected and approved MPO projects which are approved annually by Council.

FISCAL IMPACT

This is a one-time capital improvement expenditure. Funds in the amount of \$50,111.17 are available from 2002 Certificates of Obligations and authorized payable to the Texas Department of Transportation.

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget, the Finance Department and the Texas Department of Transportation.




