SUMMARY AND RECOMMENDATIONS

This ordinance authorizes additional funds in the amount of \$1,445.31 payable to County of Bexar for fee simple title to one parcel and Recording Fees in the amount of \$11.00, for a total amount of \$1,456.31 in connection with the Mockert Street Area (Mockert, Forrest, W. Lambert, Kline, and Cass) Project. This is an authorized 1999 General Obligation Street Improvement Bond funded project located in Council District 5.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Ordinance No. 96645, dated October 31, 2002, appropriated funds in the amount of \$928.00 for a portion of Parcel 16851. The City will now acquire the entire parcel, which is known as 135 Cass Avenue, to avoid the cost of condemnation, which would exceed the acquisition cost for the entire property. The property located next to this parcel will also need to be acquired, and the remainder of these two properties could be disposed of by Asset Management as a useable site for residential construction. The parcel being acquired is only 33-feet wide.

We have acquired seven parcels in the 16-parcel project. Nine parcels are still in negotiation. This project will let for contract in January 2003. Construction on this project is scheduled to begin in May 2003 and be completed in March 2004. The scope of work for this project includes the reconstruction of Klein, Cass and W. Lambert, from Mockert to S. Flores. Mockert, from Klein to Furnish; and Forest from S. Flores to Halstead and includes four-foot sidewalks, curbs, and driveway approaches.

POLICY ANALYSIS

The acquisition of this property is necessary to complete real estate transactions in this project.

FISCAL IMPACT

Funds in the amount of \$1,456.31 are available from 1999 General Obligation Street Improvement Bonds and authorized payable as follows:
