SUMMARY & RECOMMENDATION:

This ordinance authorizes the Purchasing & General Services Department to accept the bid from The Hiller Group, Inc. to provide the City of San Antonio Police Department with an annual contract for bulk jet-a-fuel. Staff recommends approval of this ordinance.

BACKGROUND INFORMATION:

The attached tabulation of three bids to provide the City of San Antonio Police Department Helicopter Detail with bulk jet-a-fuel on an annual contract basis is hereby submitted for council consideration and action. The low bid was submitted by The Hiller Group, Inc.

The Helicopter Detail Unit of the San Antonio Police Department operates four turbine powered Schwiezer helicopters. The helicopters are operated for approximately 2,000 hours annually and use an estimated 45,000 gallons of jet-a-fuel.

The City of San Antonio Purchasing Department advertises bids in the Daily Commercial Recorder, La Prensa, the San Antonio Observer and the San Antonio Express News. This office also advertises bids on Public Access Channel 21, the Purchasing Website and utilizes the services of Demandstar.com to notify registered vendors of City bids.

POLICY ANALYSIS:

The contract provides for 24-hour a day delivery of jet-a-fuel to the San Antonio Police Helicopter Detail hangar located at 1110 99th Street at Stinson Airport. The vendor will pump the fuel into the 5,000 gallon fuel tank located on the hangar ramp. This is a recurring contract, which has been in effect since the installation of an above ground fuel tank in 1998.

FINANCIAL IMPACT:

The estimated cost of this contract is \$45,000.00 annually. Funds will not be encumbered by this ordinance. All expenditures will be in accordance with the FY02-03 Budget approved by City Council.

COORDINATION:

This ordinance has been coordinated with the City of San Antonio Police Department.

SUPPLEMENTAL INFORMATION

This contract was developed utilizing the formal competitive bid process, therefore an Ethics Disclosure Form is not required.
