BIOGRAPHY OF WAYNE S. ALEXANDER



Immediately, prior to his position as Southwestern Bell president, Mr. Alexander led SBC's wireless CATV, long distance, and local telephony operations in Chile and the Asia Pacific from 1995 through 1999. Previous to these assignments he was in charge of sales for Southwestern Bell Yellow Pages, directed network and marketing for Southwestern Bell Texas, and participated in the Congressional Assistant Program in Washington, D.C.
