TACCRRA FOR THE KIDCARE RESOURCE AND REFERRAL

### SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the acceptance of State Child Care Development Funds (CCDF) in the amount of \$65,813.00 from the Texas Association of Child Care Resource and Referral Agencies (TACCRRA) to continue operating KidCare Resource and Referral services, which are administered by the Department of Community Initiatives, Children's Resource Division for the period beginning January 1, 2003 and ending August 31, 2003.

This ordinance authorizes the execution of a contract with TACCRRA and adopts a budget.

Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

The Department of Community Initiatives, Children's Resources Division (CRD), KidCare Resource and Referral (R&R) section has been providing continuous child care resource and referral support and activities to San Antonio, Bexar County and 28 rural counties in the Texas Department of Protective and Regulatory Services Region 20 since 1985. A year later, KidCare R&R became one of the founding R&R's of TACCRRA which dedicates its efforts to improving the availability, affordability and quality of early childhood care and education services in Texas.

In Fiscal Year 2000, TACCRRA set as its primary goal the establishment of a statewide Child Care Resource and Referral (CCRR) network. The network manages the daily operations of all local CCRRs and coordinates and promotes CCRR services to working families through public awareness campaigns and the Texas Workforce Centers across the state.

TACCRRA contracts with the KidCare Resource and Referral to provide services to 34 counties in three Workforce Development Areas. To accomplish this task, CRD maintains a liaison with all three Local Workforce Development Boards in the service delivery area and meets with the respective child care representatives. Additionally, CRD has traveled to all 34 counties and

briefed key city administrators, local elected officials, child care contractors, school district superintendents, and community leaders in the child care industry.

Under the TACCRRA initiative, the Children's Resources Division (CRD) provided R&R services to more than 2,900 families (servicing over 4,000 children) during the previous contract period of January 1, 2001 through December 31, 2001. In 2001, CRD served three times its contracted requirement of 868 families. The 2002 contract service requirement was 2,092 families, a goal which CRD exceeded by serving 3,118 families (4,129 children).

An immediate benefit to Bexar County and the outlying 33 counties is the on-line R&R services application. Parents can apply for R&R services without making a phone call. Their application is immediately emailed to a Child Development Specialist who in turn provides the resources available to the parent. This is accomplished by returned phone calls, faxing or e-mailing the list of resources, or mailing the list to the parent.

TACCRRA maintains a statewide database of comprehensive child care providers and participant data. This is accomplished by utilizing the National Association of Child Care Resource and Referral Agency's database software (NACCRRAware) as the state standard. The City of San Antonio is currently using this application to deliver and track child care data. Through NACCRRAware, CRD maintains their respective comprehensive child care provider and participant data for their service delivery area. NACCRRAware will complement the single portal entry system, when implemented, through database interface with participant records.

Texas Information and Resource Network (TIRN) is the umbrella agency for the 211 information resource systems. While both provide resource information to the public, R&Rs such as San Antonio's KidCare provide specialized information regarding childcare, assess individual family child care needs and provide customized child care information. TIRN agencies provide general information to the public at large.

## **POLICY ANALYSIS**

This ordinance is a continuation of existing City policy of using federal and state funding to provide early education and care services and activities. Moreover, these funds will enable the Department of Community Initiatives to continue to offer efficient and effective child care referral information to the general public.

#### FISCAL IMPACT

This ordinance accepts \$65,813.00 of federally assured Child Care Development Funds through TACCRRA. Funds are programmed to provide continued support in three specific areas of the proposed contract:

- 1) Continue collecting, maintaining, and providing TACCRRA comprehensive data on the supply and demand, and gaps of child care services,
- 2) Continue disseminating consumer and educational information to families and child care providers, and
- 3) Continue delivering presentations on CCRR services available to each Workforce Development Board and local affiliates of national child care organizations.

These funds will be utilized within the proposed contract period (January 1, 2003 through August 31, 2003). The 77<sup>th</sup> Legislature, under House Bill (HB) 1307 has authorized continued funding of the CCR&R Network through August 31, 2003. This contract concludes the current entitlement period outlined and authorized by the Legislature under HB 1307.

This program requires no General Fund support.

## **COORDINATION**

The Department of Community Initiatives coordinated activities with the City Attorney's Office, Commission for Children & Families, Finance Department, and the Office of Management & Budget.
