# SUMMARY AND RECOMMENDATIONS

This ordinance appropriates funds and providing for payment in the amount of \$17,168.31 payable to Southwestern Bell Telephone Co. from 1999 General Obligation (G.O.) Drainage Improvement Bond funds for the relocation of their underground facilities in connection with the Guilbeau Drainage at French Creek Phase I project located in Council District 7.

Staff recommends approval of this ordinance.

# **BACKGROUND INFORMATION**

The Guilbeau Drainage at French Creek Phase I project involves the installation of a storm sewer system along the parkway of Guilbeau Road between Mystic Park and the French Creek. During the review process, a conflict in alignment was identified between the underground SBC facilities and the City's proposed storm sewer. Because this project does not involve street widening or straightening, SBC will not pay for the relocation of their facilities. SBC interprets state statute (Texas Utilities Code Sec. 54.203) to require relocation of utility lines at their expense only in the event of municipal street widening or straightening. The City agrees in this instance to pay for these services while reserving its rights to later seek reimbursement from SBC. This project is currently near design completion.

The Guilbeau Drainage at French Creek Phase I project provides for the design of a storm water sewer system on Guilbeau Road from the French Creek to a point approximately 800 feet east of Mystic Park. Construction of design improvements on Guilbeau Road from the French Creek to Mystic Park are also included. This project is scheduled to advertise for bids March 2003, begin construction June 2003, and be completed by February 2004.

### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1999 G.O. Drainage Bond funded Capital Improvements Projects.

# **FISCAL IMPACT**

This is a one-time capital improvement expenditure within budget and included in the Capital Improvement Program budget. Funds in the amount of \$17,168.31 are available from 1999 G.O. Drainage Bond funds and authorized payable to SBC. The estimated construction cost for this project is \$440,071.00, design is \$88,128.00, and miscellaneous costs are \$17,168.31, which represents a portion of a total estimated City project cost of \$545,367.31.

# **COORDINATION**

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.

# **SUPPLEMENTARY COMMENTS**

The Discretionary Contracts Disclosure statement required by the Ethics Ordinance is not required.

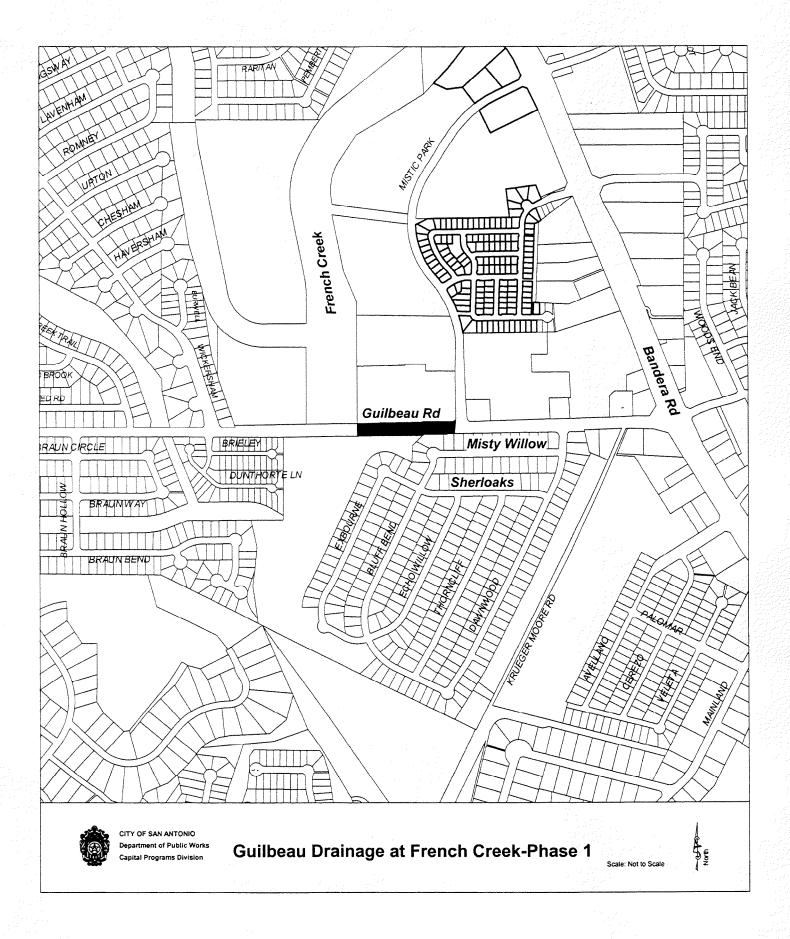

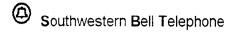

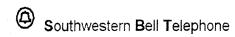
