SUMMARY AND RECOMMENDATIONS

The following Ordinance authorizes and ratifies the execution of an amendment to the existing License and Maintenance Agreement with SAP Public Services to provide the City with the GIS Business Connector software and support.

An Ordinance ratifying the execution of an amendment to the SAP Public Services, Inc. license and maintenance agreement to provide for the acquisition of proprietary software licenses for the GIS Business Connector for \$23,280 and subsequent maintenance at an initial annual amount of \$3,321; appropriating and encumbering funds and authorizing payment.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

On June 20, 2002 the City Council approved Ordinance 95976 that authorized an End User License and Maintenance agreement with SAP Public Services to provide for the acquisition of proprietary software licenses for Enterprise Resource Planning (ERP) and Customer Relationship Management (CRM) software in an amount of \$3,895,466. Within the terms of this agreement the City negotiated and locked in future pricing options which stipulated that for a period from the effective date of the license agreement through December 26, 2003 the City may purchase additional SAP functionality at the stated discount of 80.6% from the current list price in effect. The discounts were negotiated in order to provide the City the flexibility to evaluate future ERM Project needs on a case-by-case basis and determine the appropriate action to be taken as additional requirements are identified. The ERM Project team has evaluated the option of developing the GIS Business Connector internally versus purchasing the connector from SAP. Analysis has proven it is more cost effective to purchase, than to develop the interface internally. Additionally, the purchase of the Connector provides a known and workable SAP supported tool that has been tried and tested and provides a tool for future expansion of GIS functionality.

The GIS Business Connector will provide the City with the ability to connect or create a bridge between the new SAP Customer Relationship Management System and the City's GIS mapping system thereby increasing customer service to citizens of San Antonio through the City's 311 Customer Service center. GIS will be utilized to validate addresses for service requests, verify duplicate service requests by address, reports statistics on service requests as well as provide Customer Service Representatives information specific to a customer, such as garbage collection schedules, out of cycle brush collection, council district, etc.

In order to have the Customer Relationship Management Software configured and tested prior to the May go-live date, this amendment was executed on February 7, 2002. The major provisions of the GIS Business Connector amendment include the following:

- License Fee and Payment
 - List price of \$120,000 discounted by 80.6% in accordance with the End User License agreement effective June 30, 2002 for a total net license fee of \$23,280
 - Due and payable 30 days from date of invoicing
- Maintenance Fee and Payment
 - Maintenance is priced at the current factor of 17% multiplied by the net license fee of \$23,280 for an annual maintenance fee of \$3,958. (17% of \$23,280)
 - Maintenance fees are subject to change during a calendar year upon ninety days notice to the City
 - Maintenance fees are invoiced annually on January 1, any maintenance fees due prior to January 1 are invoiced on a pro rata basis. As a result, the first years maintenance is \$3,321 for the period March 2003 through December 2003.

POLICY ANALYSIS

Execution of the GIS Business Connector amendment to the End User License Agreement with SAP Public Services, Inc., is consistent with previous City Council actions to facilitate the implementation of an Enterprise Resource Management System.

FISCAL IMPACT

This ordinance appropriates and encumbers \$23,280 payable to SAP Public Services Inc. for the acquisition of proprietary software licenses for the GIS Business Connector.

The amount appropriated for the first year of maintenance and support is \$3,321 (pro rated for March through December) to be funded from Certificates of Obligations or other available funds. The remaining years of service and maintenance will be funded through the annual operating budget process in an amount not to exceed the current maintenance factor in effect (currently 17%) multiplied by the net-license fee of \$23,280 for an amount of \$3,985 for each subsequent year.

These amounts are programmed within the ERM Project Budget. The hardware and software budget estimated at the beginning of the project considered future unidentified hardware and software needs that would be determined as the project progressed. The combined hardware and software budget for the ERM Project is \$15,635,500 of which \$12,589,097 has been obligated through previous Council actions for items such as SAP Software, Hansen Software, Software Maintenance, initial computer Hardware purchase, Oracle Database and Crystal report writer.

As a result, a sufficient balance of \$3,046,403 is available for purchase of the SAP GIS Connector.

COORDINATION

This amendment to the SAP End User License agreement for the GIS Business Connector was coordinated with City Attorney's Office, Information Technology Services Department and Finance Department.
