### **SUMMARY AND RECOMMENDATIONS**

Ordinance to restore the name of Durango Blvd., between IH 37 on the east and IH 35 on the west; providing that the same section of the street have the honorary name Judge HF Garcia Memorial Blvd; and that the City's code procedure for naming and renaming city streets be waived due to the unique situation and to expedite this process.

Staff recommends approval.

### **BACKGROUND**

On December 12, 2002, an ordinance was approved to change a portion of Durango Blvd., between IH 37 on the east and IH 35 on the west, to HF Garcia as submitted by Councilman Bobby Perez. Subsequent to this action, a six-signature memo is now requesting the City to consider restoring the name of Durango Blvd. to the section of street named HF Garcia Blvd pursuant to Ordinance 96809. In addition, the memo requested that this section of the street have the honorary name of Judge HF Garcia Memorial Blvd. The Governance Committee reviewed the six-signature memo at their meeting on February 26 and agreed to have this item placed on the Council agenda for March 6, 2003.
