### **SUMMARY AND RECOMMENDATIONS**

This ordinance would appoint the following individuals to the Convention Center Hotel Advisory Board (CCHAB) that was created by City Council: Finance/Banking Sector: Ruben Escobedo, Adam Garza and Joe McKinney; Real Estate/Corporate Sector: Henry Feldman (Hotel/Tourism Industry), Julianne Galloway and Barbara Gentry; Community Appointment: Richard Terrell.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

On February 13, 2003, the City Council was updated on the status of the Convention Center Hotel Project. At that briefing, City Staff recommended the creation of the Convention Center Hotel Advisory Board (CCHAB) that would include local experts, not affiliated with any of the RFQ respondents, who could assist the City Council in formulating recommendations and focus on expediting the hotel development process.

After becoming familiar with the project and financing issues, it is envisioned that the CCHAB would make recommendations about how the City Council should proceed with the following activities:

- 1. Ranking existing responses
- 2. Selecting a financial design
- 3. Identifying the top-ranked developer
- 4. Project timing

The Advisory Board will consist of seven members serving four-year staggered terms, appointed by City Council. The following individuals have been nominated by City Council to serve on the Board from the industry/community groups specified below:
