## **ZONING CASE NO. Z2003015** February 18, 2003

Applicant: Earl & Brown, P. C. on behalf of Continental Homes, Inc.

Zoning Request: "C-3" Commercial District to "R-4" PUD Residential Single

Family Planned Unit Development District.

Ken Brown, 111 Soledad, representing the owner, stated this is a 19 acre tract that consists of 71 lots. He further stated they are proposing to develop single-family residential subdivision. He also stated there are no access roads on Prue and Springtime Road.

Staff stated there were 64 notices mailed out to the surrounding property owners, 1 returned in opposition and 9 returned in favor and no response from Babcock North Neighborhood Association and Country View Village Homeowners Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

### **COMMISSION ACTION**

The motion was made by Commissioner Morell and seconded by Commissioner McAden to recommend approval of "R-4" PUD.
