The "R-5" Residential Single-Family District would be an appropriate zoning classification and transition for the 39.431 acre tract. The City of San Antonio Master Plan encourages infill development on vacant lots throughout the entire community.

Applicant: JRJAHA, Ltd.

Zoning Request:

"C-2" Commercial District, "C+3" Commercial District and "MF-33" Multi-Family

District to "R-5" Residential Single Family District.

<u>Craig Bloom</u>, 228 Losoya, representing the applicant, stated their intent is to develop residential single family dwelling on the subject property. This development would consist of approximately 214 lots. He stated they have been in contact with the People Active In Community Effort and the Valley Forest Neighborhood Association and South San I. S. D. who are in support of this request.

Staff stated there were 23 notices mailed out to the surrounding property owners, 0 returned in opposition and 6 returned in favor and no response from People Active In Community Effort.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
