**TIA Statement:** 

A traffic impact analysis is not required.

#### Staff Recommendation:

Denial.

The vacant subject tract fronts Leslie Road which, at this location, acts as a two-way frontage road for Loop 1604. The subject property is completely surrounded by "R-6" Residential Single-Family zoning. Residential uses are scattered throughout the general vicinity, including adjacent property to the south and west. Commercial zoning classifications, such as the one requested in this case, are encouraged at intersections of major arterials. While Shaenfield Road is proposed to eventually be a secondary arterial, the subject site is separated from it by residentially zoned tracts, making "C-2 NA C" at this location incompatible with surrounding uses and zoning.

Commercializing thoroughfares in such a piecemeal fashion is also inappropriate planning practice. If the requested rezoning is approved, an island of commercial zoning would be situated adjacent to existing residences.
