SUMMARY AND RECOMMENDATIONS

This ordinance approves a lease agreement renewal with operation changes with the San Antonio Gun Club for use of property in Olmos Basin Park in City Council District 9 for a 25 year term.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The San Antonio Gun Club, a non-profit corporation, has operated a recreational gun club on 76 acres of City property located in Olmos Basin Park in City Council District 9 since the 1920's. The Club is located off of Contour Drive west of U.S. 281. The most recent lease agreement expired last year and the City, the San Antonio Gun Club and local property owners have been negotiating the contract over the past several months to resolve various issues associated with the operation of the Gun Club.

The **previous leases** for the operation have been in 25 year increments, with many of the terms and conditions repeated from lease to lease. The most recent lease, approved in 1977, <u>did not</u> restrict, limit or control major aspects of the Gun Club, to include hours of operation, well defined use of leased property, noise control, overnight camping, alcohol consumption, etc. In addition, the City was identified as the responsible party for utility payments, building repairs and grounds maintenance.

The **proposed lease** renewal, also for 25 years, is based upon several operational changes and restrictions to help address concerns expressed by the adjacent Olmos Park neighborhood and the City of San Antonio. The new lease includes restricted hours of operation:

- Mondays, closed
- Tuesday Saturday, 11:00 a.m. 7:30 p.m.*
- Sunday, 11:00 a.m. 6:00 p.m.*
- * or official sunset, whichever is earlier

- Closed all Fridays from Thanksgiving to December 23rd
- Closed from December 23 January 1
- Closed Mother's Day, Easter, Thanksgiving

It also includes a restricted number of registered shoots/tournaments to 14 weekends per year, limits the number of participants to maximum of 90, restricts use of certain shooting fields, restricts alcohol consumption, requires environmental cleanup, and eliminates overnight camping. The lease also transfers all building repair, grounds maintenance and monthly utility costs from the City to the Gun Club.

POLICY ANALYSIS

This ordinance is consistent with the City's customary approval of leasing public property to entities that provide recreational opportunities to the citizens of San Antonio.

FISCAL IMPACT

The City is currently responsible for annual expenditure commitments for the Gun Club, to include building repair, grounds maintenance and utilities, at an estimated annual cost of \$15,000.00. Under the new lease, the City will no longer be responsible for any obligation or costs.

COORDINATION

This item was coordinated with the City Attorney's Office, Asset Management, Environmental Services, City Council District 9 office, neighborhood representatives and the City of Olmos Park. It was presented to the Quality of Life Committee on May 22, 2003 and it received favorable review.
