SUBJECT: ORDINANCE ACCEPTING FUNDS FROM THE NATIONAL INSTITUTE

OF ENVIRONMENTAL HEALTH SCIENCES (NIEHS)

DATE: June 5, 2003

SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the acceptance of a cash grant in the amount of \$50,000.00 from the National Institute of Environmental Health Sciences (NIEHS) for the San Antonio Metropolitan Health District (SAMIID) to conduct an effort meant to increase community involvement in environmental health issues during the period June 1, 2003 through May 31, 2004. This ordinance also adopts the project budget and authorizes payments for an outside facilitator and printing services.

Staff recommends approval.

BACKGROUND

The National Institute of Environmental Health Sciences (NIEHS) is one of 27 Institutes and Centers of the National Institutes of Health (NIH), which is a component of the Department of Health and Human Services (DHHS). The NIEHS supports biomedical research programs, prevention and intervention efforts, and communication strategies that encompass training, education, technology transfer, and community outreach. NIEHS has offered a cash grant in the amount of \$50,000.00 to the San Antonio Metropolitan Health District (SAMHD) to support an effort meant to increase community involvement in environmental health issues. The effort will use a guidance tool known as the Protocol for Assessing Community Excellence (PACE) and be conducted during the period June 1, 2003 through May 31, 2004.

Through this grant SAMHD will establish a working Community Health Environmental Coalition (CHEC) that will serve as a resource for the City when addressing environmental health concerns. The goals of the CHEC will be to maximize community participation and ownership, maintain an environmental health focus in San Antonio, and secure commitments of multi-organizational resources to address the environmental health concerns of the City. Specifically, the CHEC will work to assess San Antonio's environmental health status, develop an action plan, rank public values and priorities pertaining to environmental issues, and address the existing gaps in environmental health resources in San Antonio. This effort has been coordinated with Code Compliance and Environmental Services Departments.

POLICY ANALYSIS

This ordinance follows past City policy of fostering the development and maintenance of cooperative relationships with community programs that increase awareness, access and participation of residents in health and environmental programs.

FINANCIAL IMPACT

This NIEHS cash grant provides \$50,000.00 to support the PACE Environmental Health Education Program that will complement the National Association of City and County Health Officials (NACCHO) Project of the SAMHD. Acceptance of this cash award will place no demands on the City General Fund.

COORDINATION

The Finance Department has approved the proposed project budget.

SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.
