The South Central San Antonio Community Plan indicates Office/Light Commercial along Plesanton Road and Low Density Residential. There is "R-6" Residential Single-Family District to the east, north, Harlandale High School to the south and "C-2NA" Commercial District Non-Alcoholic Sales to the north along Pleasanton Road. The Planning Commission denied the requested plan amendment at their April 23, 2003 meeting.

Applicant: Susan M. Guerra

Zoning Request: "R-6" Residential Single-Family District to "C-1" Commercial District.

<u>David Rodriguez</u>, representing the applicant, stated they are proposing a childcare center with the possibility of a restaurant with no alcohol sales on the subject property. He stated the childcare facility has been in operation since 1996. He stated he would like to amend his original request to "C-2NA".

Staff stated there were 26 notices mailed out to the surrounding property owners, 4 returned in opposition and 3 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
