Applicant: B & M Real Estates, Ltd.

Zoning Request: "C-3NA" Commercial Non-Alcoholic Sales District to "C-3"

<u>Charles Eden</u>, representing the applicant, stated they are proposing to operate a Wing Stop Restaurant on the subject property.

OPPOSE

<u>Dr. Ralph Schneider</u>, stated his office is within the area of the proposed zoning change. He expressed concerns with this sale of alcohol at this business. He feels this operation would only add to the alcohol problems within this area.

<u>Dr. Mora</u>, stated he is in opposition of this request. He stated he feels this operation is inappropriate for this area. He further stated this would have a negative impact for this area.

Staff stated there were 22 notices mailed out to the surrounding property owners, 15 returned in opposition and 4 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
