<u>Doyle Walsh</u>, applicant, they are requesting this change in zoning to allow an athletic training Facility. This facility would consist of indoor courts for volleyball and basketball. The exterior grounds would contain soccer training field and 2 outdoor basketball courts. He further stated this gymnasium would not contain shower facilities.

Staff stated there were 24 notices mailed out to the surrounding property owners, 0 returned in opposition and 7 returned in favor and no response from Oak Park Northwood Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
