SUMMARY AND RECOMMENDATIONS

This ordinance amends a professional service contract and authorizes Certificates of Obligation funds in the amount of \$30,000.00 payable to K.M. Ng & Associates, Inc., for engineering services in connection with Houston from Bowie to Pine project, an authorized Metropolitan Planning Organization (MPO) project, located in Council Districts 1 and 2.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

This ordinance approves additional compensation to K.M. Ng & Associates, Inc., for engineering services to include construction administration of the Houston from Bowie to Pine project. This project provides for the reconstruction of the existing 2-lane roadway to 2 lanes at railroad tracks and 4 lanes in other areas to include curbs, 4-foot sidewalks at the curb, driveway approaches, and necessary drainage. This project is Phase II of the Houston Street project, which is currently under construction and is scheduled for completion by February 2005. Phase III includes Pine to Walters and is scheduled to let in October 2003.

As part of the implementation of Metropolitan Planning Organization (MPO) Surface Transportation Program projects, it is the City's responsibility to fund engineering, right of way acquisition, and twenty percent (20%) of construction cost.

This professional services contract was originally approved by City Ordinance No. 81897 on March 23, 1995, and initially authorized \$117,000.00 for services related to this project. Subsequent City Council action authorized additional funds in the total amount of \$93,361.00 and brought the total contract value to \$210,361.00. This City Council action will increase the total, to date, authorized for this professional service contract to \$240,361.00.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to participate in the development and construction of City selected and approved MPO projects which are approved annually by Council.

FISCAL IMPACT

This is a one-time capital improvement expenditure within budget and not included in the FY 03-08 Capital Improvement Program Budget. Funds in the amount of \$30,000.00 are available from Certificates of Obligation and authorized payable to K.M. Ng & Associates, Inc. This item represents a portion of the total estimated City project cost of \$954,445.00.

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget, the Finance Department, and the Texas Department of Transportation.


