SUMMARY AND RECOMMENDATION

This ordinance shall amend the composition to the Citizens Commission on City/County Service Integration by increasing the membership to eleven (11) members for the City and eleven (11) members for the County thereby totaling twenty-three (23) members on said Commission.

BACKGROUND INFORMATION

On September 25, 2003, the City Council approved an ordinance to create the Citizens Commission on City/County Service Integration. The Commission was originally established with twenty-one (21) members, ten (10) appointed by the City of San Antonio, and ten (10) appointed by the Bexar County Commissioners Court, and the Chair to be appointed jointly by the Mayor of San Antonio and Bexar County Judge. On October 2, 2003, an ordinance was approved appointing the ten members to represent the City of San Antonio.

POLICY ANALYSIS

Approval of this ordinance is consistent with the City's policy to collaborate with Bexar County on new initiatives to integrate service delivery to citizens as a means of enhancing the quality and effectiveness of existing services at a reduced cost to the taxpayer.

FISCAL IMPACT

There is no financial impact associated with this ordinance.

COORDINATION

This ordinance has been coordinated with the Mayor's Office, City Attorney's Office, and Bexar County.
