#### **SUMMARY AND RECOMMENDATION**

This ordinance authorizes 1999 General Obligation Street Improvement Bond funds in the amount of \$333,850 for acquisition of fee simple title to certain privately owned real property and other miscellaneous expenses associated with the Tezel - Timber Path to Old Tezel Metropolitan Planning Organization Project located in Council District 7. This ordinance authorizes City staff to acquire these properties at fair market value by negotiation or condemnation, if necessary.

Staff recommends the approval of this ordinance.

## **BACKGROUND INFORMATION**

We have eight signed instruments in the nine-parcel project. One parcel is still in negotiations. The project is scheduled to be advertised in January 2004 by the Texas Department of Transportation, start construction in February 2004, and be completed by June 2005. The scope of this project includes the reconstruction and widening of the street to 72-feet (four lanes) with turn lanes, curbs, six-foot sidewalks at the curb, drainage, signal improvements, and six-foot bicycle lanes.

#### **POLICY ANALYSIS**

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1999 General Obligation Drainage Improvement Bond funded Capital Improvement Projects.

### FISCAL IMPACT

This is a one-time capital expenditure within budget and included in the FY03-FY08 Capital Improvement Program Budget. Funds in the amount of \$333,850 are available from 1999 General Obligation Street Improvement Bonds. This item represents a portion of a total estimated City project cost of \$3,889,104.

#### **COORDINATION**

This ordinance was coordinated with the City Attorney's Office, the Finance Department, and the Texas Department of Transportation.


