SUMMARY AND RECOMMENDATIONS:

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with the DAM '09 Triathlon being held on Saturday, August 30, 2003. The parade will assemble and disband at Alamo Heights Swimming Pool. The route is attached.

Staff recommends approval of this ordinance.

POLICY ANALYSIS:

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

COORDINATION:

This event has been coordinated with the City Manager's Office, the Traffic Section of the Police Department, and the Traffic Division of the Public Works Department. All of the involved city departments concur with the staff recommendation to approve this request.

FINANCIAL IMPACT:

All insurance requirements, public safety devices (signs, barricades) and any off-duty police as may be required by the Police Department or the Public Works Department shall be the responsibility of the event sponsor, Roger Soler's Sports. The City will receive revenues of \$25.00 from this event and will incur no additional costs.

The requirements of the Ethics Ordinance are not applicable.

ROUTE FOR PARADE/RUN

START TIME 7:00 AM

THE TRIATHALON WILL BEGIN AND END IN OLMOS PARK. THE PARTICIPANTS WILL BE STARTED IN STAGES. ALL PARTICIPANTS WILL NOT BEGIN AT THE SAME TIME. THE SWIMMING PORTION WILL TAKE PLACE IN OLMOS PARK. THE RUN WILL TAKE PLACE IN OLMOS PARK, ALAMO HEIGHTS AND SAN ANTONIO. THE CYCLING EVENT WILL ALSO TAKE PLACE IN OLMOS PARK, ALAMO HEIGHTS AND SAN ANTONIO.

RUN ROUTE:

THE RUN WILL BEGIN IN OLMOS PARK AND WIND THROUGH THE BASEBALL FIELDS. IT WILL EXIT OUT ONTO DEVINE (CITY OF SA) AND TRAVEL SOUTH APROX 50 YARDS. AT THAT POINT THE RUNNERS WILL RUN EAST INTO THE SOCCER FIELDS AND FINISH THE RUN INSIDE OLMOS PARK.

CYCLING ROUTE:

EXIT PARK SOUTH ON CRESCENT TO OLMOS. (ALAMO HTS)

WEST ON OLMOS TO DEVINE. (ALAMO HTS, S.A., OLMOS PARK)

(ALAMO HTS, S.A., OLMOS PARK) NORTH ON DEVINE TO ALAMO HEIGHTS.

EAST ON ALAMO HEIGHTS TO VIESCA (ALAMO HTS) SOUTH ON VIESCA INTO PARK. (ALAMO HTS)

NOTE: THE ONLY INTERSECTION IN S.A. CITY LIMITS THAT THE RUN OR CYCLING EVENT WILL EFFECT IS AT DEVINE AND DICK FREDRICH, AT THAT LOCATION THERE SHOULD BE NO NB TRAFFIC ON DEVINE UNLESS THE RUN HAS COMPLETED AND THERE ARE NO CYCLIST TO INTERFERE WITH VEHICULAR TRAFFIC.
