Applicant: A. S. M. Ferdous, DBA Investment Ideas, L. L. C.

Zoning Request: "O-2" Office District & "NP-10" Neighborhood Preservation District to "R-6" Residential Single Family District.

<u>Alejandro Gomez</u>, representing the owner, stated they are proposing to construct a 36 single-family residential unit on the subject property.

OPPOSE

Rose Ryan, 7950 Clyde Dent Drive, stated she is in opposition of the proposed development. She expressed concerns with the increase in traffic and noise levels this development would bring into the neighborhood. She stated she feels this would have a negative impact on the community.

REBUTTAL

A. S. M. Ferdous, owner, stated he has conducted a traffic study of the area and this particular development would increase the traffic flow in the area. He further stated this development would enhance the appearance of the neighborhood.

Staff stated there were 32 notices mailed out to the surrounding property owners, 2 returned in opposition and 2 returned in favor and no response from Misty Oaks Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
